

# 2008 Ballston Arts and Crafts Market Application

**When** May through October, second Saturdays, 10am to 4pm.  
May 10, June 14, July 12, August 9, September 13 & October 11, 2008

**Where** Welburn Square at Ballston Metro. between Wilson Blvd and Fairfax Drive on N. Stuart Street.

**Eligibility** Artists must be 18 years of age or older. All fine craft and art media are accepted including, but not limited to: clay, fiber, furniture, glass, jewelry, leather, metal, paper, wood, original painting, drawing, photography, sculpture, fiber art, clothing, accessories and mixed media works. Work for each event must be original and executed by the accepted artist vendor. Mass-produced, commercially produced items are not eligible. Only limited edition prints from one source, hand-pulled, signed and numbered by the artist, will be permitted

**Fees** \$50 per space per market / \$45 per space per market if the artist commits to 3 or more market days. (Do not send payment at this time.)

**Submission and Acceptance** Submissions will be accepted via regular mail and email. The Deadline for the first round of jurying is Monday, March 3<sup>rd</sup>, 2008. After the initial deadline, artists may be admitted on a rolling, space-available basis. Upon acceptance artists will receive full details of market participation and market fees will be due.

**Exhibit space** Each exhibitor will be assigned a 10' x 10' space. Each artist is responsible for providing their own tent, tables, chairs and displays. Requests for double spaces will be considered and are subject to availability. Accepted Exhibitors who sign up for 4 or more markets will be eligible for an assigned space that is the same throughout the season.

**Exhibitor Responsibilities** Exhibitor is responsible for delivery, handling, set-up and removal of his/her own display and materials. Each artist vendor must provide their own free standing 10' x 10' canopy which must be anchored with appropriate weights (the square can get windy!). No electricity is provided. No banners other than your name may be displayed without Art Market approval. The registered exhibitor must be present during the event. Exhibits must remain intact during the entire duration of the art market (10am – 4pm)

**Inclement Weather** The Art Market is scheduled rain or shine, but in case of severe weather, a decision will be made as soon as is reasonable given weather conditions, and artists will be notified. Those artists will then be eligible to participate on an alternate date. The decision to cancel a market due to inclement weather will be made by the market manager and only then will artists' fees be credited for an alternate date.

## **Jury**

The Art Market Review Panel is made up of a rotating panel of area arts professionals.
